Gossip

We hope that you are not taking your “right to the road” too much for granted. First off, any traffic court judge would be happy to remind you that you have no “right to the road.” **Road use**, they like to say, **is a privilege and privileges can be revoked**. So when you hear us complaining about a crappy bicycle law or cops kicking cyclists off the Metroparks Parkways, **please take heed**. We’re complaining aloud to try and draw attention to a situation about which something can be done.

Fortunately, a few cyclists can recognize a threat when it comes up and bites them in the Lycra. **Fred Oswald, P.E.** has been diligently studying the situation and has compiled **quite a lot of scary stuff** which is available at the *CrankMail* Web site. Of course, just complaining, compiling, and being scared by these things isn’t nearly enough. Fred, a Lake Erie Wheeler, has also been **working with the Ohio Bicycle Federation** to try and bring some **relief to cyclists across the state** in the way of reformed laws. ’See, the Ohio Revised Code, as it applies to bicycles, isn’t too bad. But that same Ohio Revised Code allows local communities to make up their own traffic laws. So, while the state law might consider bicycles vehicles and allow their use on the streets and roads, **North Olmsted, for example, can say you must ride on the sidewalk and walk your bike through every intersection**. Funny thing is, unless local police enforce the screwy local variations on a traffic law theme, you might not even know about ’em. Lets say you were riding in the street in North Olmsted and **a crummy driver pulls along side you and then makes a right turn**, smashing you into the right side of their car and knocking you into the gutter and on to the curb. **Your bike is demolished and you**

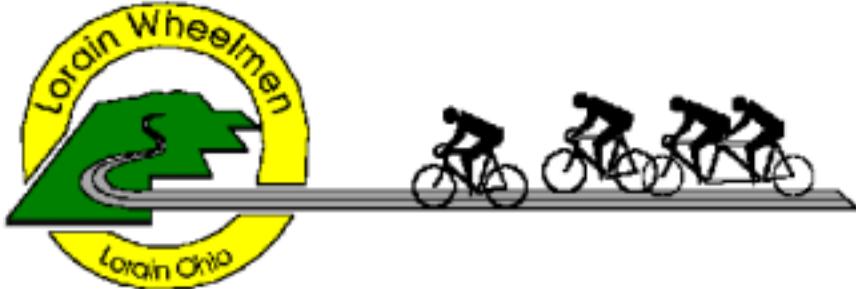
escape with a broken arm, some nasty bruises, and road rash. The local cops arrive on the scene, summon an ambulance for you. You and the driver of the car tell your stories. Then YOU are cited. **The accident, you are told, is your fault because you were not supposed to be in the street.**

The Crank is no lawyer, but we guess that what might happen next is, despite the driver’s harebrained and reckless actions, YOU are responsible for your medical bills, replacement of your beloved bicycle, the fine for a traffic violation, and damage to the guy’s car — you scratched his paint and dented his door! Actually, someone told us a true horror story very similar to this. **The point of all this?** Well, actually there are two: **First, just because a law isn’t being actively or famously enforced doesn’t mean it won’t be** or that it can’t cost you. *You may already have no privilege of road use and not even know it...yet.* And **secondly, don’t expect Fred or anybody else to fix this for you.** Each community can have different laws from the next. Check out the situation in your own town and, if it’s bad for biking, talk to your councilperson — they owe you their attention and are supposed to work for you. If you need advice on better laws or how to fix what you’ve got, there’s plenty out there. Start with the *CrankMail* Web site and Fred’s gold mine there.

We stopped by the Century Cycles store in Rocky River the other day and spotted something unusual leaning against one of the glass counters — a bike frame that had been stripped of paint. Drawing closer we began to notice that **it looked like a tandem ... no, a triple... no, a.... gad! it’s got six seat posts!** and wheels that could’ve come off a motorcycle!! Owner Scott had acquired an antique bike that someone had been meaning to restore and never got around to. When it’s repaired, repainted, and reassembled we’re sure it will be a glorious, and curious, piece well worth the effort. We hope to bring you a photograph of this bicycle next issue and, perhaps, a little more of its story.

Tuesday Morning Rides Again!

We are starting earlier this year, the third Tuesday in April for a special ride:

Tuesday, April 18, 9:15 Meet at Boston Store in CVNRA, on Boston Road off Riverview Rd. Ride the towpath to see the Heron Rookery, 25 miles, flat.

Tuesday, May 2, 9:15 Meet at Squires Castle, North Chagrin Metropark, on River Road. Ride to Chagrin Falls for muffins, 30 miles, rolling.

Effective Immediately!

By a unanimous vote of 7 to 4, the CTC Board of Trustees has decided to make **kickstands mandatory** on all bikes on club rides, **effective April 1, 2000!** All cyclists who do not have the required equipment on their bikes will be denied access to the ride that day, and anyone attempting this twice will be summarily and physically **ejected from the club**. Their **bike will be confiscated** and donated to a worthy charity designated by the Board members, most likely the members' garages.

This draconian act has been precipitated by a threatened dramatic increase in club insurance for damaged bikes. It stems from a disastrous occurrence resulting in damage to over 2 dozen bikes and the near utter destruction of a club member who shall remain nameless.

It seems on a ride last summer, to Phlogiston Lake, there was a lack of convenient railings and bench supports on which to lean the bikes. One member inadvertently managed to brace his bike against the door to the men's room. Several other

members then took it upon themselves to brace their bikes against the first bike. Seeing the lineup of bikes, a full half of the club riders braced their bikes against the second group of bikes. Unfortunately someone was in the men's room at that time. That someone was one of our club members. Upon opening the door he was... well, you can imagine. One astute member called the resulting mayhem a near-perfect example of the domino effect.

The member who opened the door is still recovering from his wounds. Most of the two dozen bikes were carbon fiber frames that shattered on impact and the remaining upright bikes all received punctures from the shards. I can tell you it was one awful mess sweeping up all that carbon. We are still negotiating with our insurance company over the matter. So remember, from now on, it's kickstand or kick butt!



This is a ride for everyone to enjoy and an opportunity to put in some early season miles. The route will be over mostly secondary roads and the terrain is generally flat. Tour the historic towns and villages of Lorain County on the same day as the Paris-Roubaix but without the cobbles. There will be one route with three cutoffs to provide routes of 25, 50, 64 and 100 miles.

Although this is a FREEBIE ride, there will be a map and the routes are marked with arrows on the road. All riders will be **required to wear an approved helmet** to participate in AFROST. There will be no SAG wagon, ride patches, or food stops. There are many places to buy food along the routes.

Donations of no more than \$.50 will be accepted on the day of the ride to cover the cost of printing of the maps.

Registration will be from 8:00 AM to 9:30 AM and leave at your leisure. Registration, start-finish and parking will be at the Nordson Depot on Franklin Ave. (just off Jackson St.) in Amherst.



Athens to Host 2000 Collegiate Road Nationals

COLORADO SPRINGS, Colo. (Feb. 28, 2000) - USA Cycling, the national governing body for the sport of cycling, has selected Athens, Ohio and the Ohio University Cycling Team as the site and host for the 2000 National Collegiate Cycling Association Road Championships, it was announced Monday.

The event will be held May 12-14, 2000. The tentative schedule of events includes a road race on Friday, the criterium on Saturday, and the team time trial on Sunday. The University of Colorado is the two-time defending national road cycling champion.

"For the MWCCC (Midwest Collegiate Cycling Conference) this will be very unique opportunity for our conference. While the MWCCC has hosted a number of collegiate track and mountain bike national championships, this will be the first road championship," said Seth Pizzo, the conference director for the MWCCC.

"Ohio University has some of the most challenging road racing terrain in the conference and the city of Athens has been the site of the now famous A to Z Classic. The A to Z Classic was a series of races which begin with a "brick" criterium in the city of Athens on one day and finished with a point-to-point road race to the city of Zanesville, Ohio the following day. The criterium course has seen many famous riders compete over the cobblestone streets, such as Greg LeMond, immediately after winning his final Tour de France."

Athens, Ohio, which is the home of Ohio University, is nestled in the foothills of the Appalachian Mountains, making for a steeply rugged and beautiful terrain. Riders will find extremely challenging venues in this southeast corner of the state, including the famous Brick Criterium course through uptown Athens whose cobblestone streets and abrupt hills have drawn favorites such as Greg LeMond and Frankie Andreu.

Tyler Hamilton, who is a member of the U.S. Postal Service Team, and 1996 Olympic road cyclist Alison Dunlap are among the standout road cyclists who have competed at previous NCCA Championships.

USA Cycling is the national governing body for the sport of cycling in the United States, and has more than 90,000 members. The USCF is the road and track cycling, and cyclo-cross association within USA Cycling.


