# Ohio Bicycle Awareness Day Arrives With Spring

COLUMBUS — Coming March 21 to the Ohio Capitol Statehouse is Bicycle Awareness Day. Sponsored by the Ohio Bicycle Federation (OBF), the day's events are to increase public awareness of all forms of bicycling, to provide an opportunity for the state's cycling community to come together in support of its sport, and to help Ohio legislative and executive leaders, and Ohio news media to become better acquainted with bicycling in Ohio.

The OBF has reserved the Atrium at the Statehouse for Bicycle Awareness Day events. Exhibits and presentations will take place there. A bicycle rally will take place midday. Organizers hope to have representatives of all forms of bicycling — recreational road, commuter, racing, off-road, BMX, police patrol, and messenger — ride to the Statehouse for a site near downtown to meet the media, eat, and participate in Atrium events and ceremonies. Gov. Taft is expected to preside over a noontime formal ceremony.





We need a **volunteer** to continue this ride in the future. **Contact Marty Cooperman** if you'd like to do this ride in the years to come (216) 932-6159.



# Commuter Ticketed as Traffic Impedement

TROTWOOD — That day in July started as a normal day for Steve Selz. He rode through Trotwood on Salem Avenue as he had done so many times before. Selz is a transportation bicyclist who does not own an automobile.

The normality of that day ended abruptly when Selz was pulled over by a Trotwood Police patrol car. Selz was issued a ticket for impeding traffic under a section of the city's ordinances which reads as follows:

“(a) no Person shall stop or operate a vehicle at such a slow speed as to impede or block the normal and reasonable movement of traffic, except when stopping or reducing speed is necessary for safe operation or to comply with law.”

Selz was surprised to be given a ticket, particularly since Salem Avenue, at that point, has five lanes, providing motorists plenty of room to move around a bicyclist. Also, Selz said, he was riding in the right tire tracks of the right lane, in no way blocking traffic.

On Monday, Feb. 7, Selz faced a judge over the citation. The Montgomery County Court found him guilty and fined him \$100. Selz would like to appeal his conviction, but money is a problem. Cincinnati attorney/bicyclist Steve Magas has offered his services to Selz at a greatly-reduced rate, but estimates that the appeal will cost at least \$1,500.

One might say that all Ohio bicyclists faced trial with Selz on Feb. 7. Ordinances like Trotwood's lend themselves to arbitrary enforcement against cyclists and are not uncommon across the state. The Ohio Bicycle Federation has established a Legal Defense Fund to provide assistance in fighting unfair legal situations. ## Ride Carefully, "Deer!"

It seems there has always been a lack of mountain bike trails in Northeastern Ohio thus limiting the use of MtBs. Now there's a pamphlet, published by Ohio Department of Natural Resources, on the Mountain Bike Trails at the West Branch State Park on Rock Spring Road off Route 5 east of Ravenna, Ohio.

The park has six trail loops totaling five miles and an out and back cable line trail of 3.4 miles round-trip. The map suggests there are three loops along the Kirwan Reservoir and three loops that are hillier.

An unusual cautionary note on the map reads: "Mountain Bike trails are located in the park hunting zones. Typical hunting seasons are from early September through the end of February and from mid-April to mid-May. Please take caution."

So now that there are trails so cyclists don't have to worry about getting hit by a car, you now have to dodge the flying bullets.


